This Privacy Policy document contains types of information that is collected and recorded by Easy Microfinance and how we use it.

This Privacy Policy applies only to our online activities and is valid for visitors to our website and users of our Android Mobile App with regards to the information that they shared and/or collect in Easy Microfinance. This policy is not applicable to any information collected offline or via channels other than this website.

## Consent

By using our website and/or our Mobile App, you hereby consent to our Privacy Policy and agree to its terms.

## Information we collect

If you contact us directly, we may receive additional information about you such as your name, email address, phone number, the contents of the message and/or attachments you may send us, and any other information you may choose to provide.

When you register for an Account, we may ask for your contact information, including items such as name, company name, address, email address, and telephone number.

The Easy Microfinance Website collects the following information:

- Standard visitor number statistics.
- The data you share with us when you apply for a loan online.

The Easy Microfinance Android App collects the following information:

- The information provided during the registration of the app (Names, NRC, Client number, Phone Number and secret questions), which will be used only for the purpose of identifying you and providing you access to your loan and deposit information and transactions in the banking software.
- The App version you are using.
- Some device information (OS version, whether your phone is rooted or not, and your location).

## How we use your information

We use the information we collect in various ways, including to:

- Provide, operate, and maintain our website and Android Mobile App
- Improve, personalize, and expand our website and Android Mobile App
- Understand and analyze how you use our website and Android Mobile App
- Develop new products, services, features, and functionality
- Communicate with you, either directly or through one of our partners, including for customer service, to provide you with updates and other information relating to the website and Android Mobile App, and for marketing and promotional purposes
- Send you emails
- Find and prevent fraud

## Log Files

Easy Microfinance follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

## Advertising Partners Privacy Policies

The right to erasure – You have the right to request that we erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that we restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to our processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that we transfer the data that we have collected to another organization, or directly to you, under certain conditions.
